Dear Governor Dayton,

My name is Stuart Ronaldson, I hold the office of the Governor for the Government of The United States of America.

I am writing because it has been brought to my attention by the Human Rights Tribunal International that your administration has in its judicial branch one, Glenn Joseph DeRusha, wherein his person belongs to the Government of The United States of America at the political decision of Glenn Joseph DeRusha. Please let this letter serve as a formal request from this office to your office for prompt assistance in resolving this international political incident.

Glenn Joseph DeRusha is a documented American National, with no political affiliations with U.S. political parties, no memberships or associations with the American Bar Association, nor any valid pledge to the United States of America. The Judicial Branch of the State of Minnesota has already recognized that Glenn Joseph DeRusha holds the status of non-citizen, non-resident alien to the United States of America. Therefore, the State of Minnesota and the Minnesota State Bar Association have no jurisdiction in this matter, yet your judiciary has held this person in excess of sixty (60) days.

In a sincere attempt to resolve this international incident, our ambassadors have reached out to your State representatives seeking assistance. No significant assistance was provided where said assistance has been rendered promptly in other States. We have also approached your judiciary numerous times and Ramsey County remains adversarial by using the non-recognition game to hide evidence and escape international liabilities. One justice has recused himself from the case, and yet, the Government's person is still illegally held in your possession. Apparently, too many members of your administration and judiciary lack appropriate knowledge of international law supported by the Law of Nations, the Universal Declaration of Human Rights and other United Nations' declarations.

The Governor of the State of Minnesota is interfering with the obligations of the North American National Party to uphold the human and political rights of its constituency. This is unacceptable and, as you know, a political crime when perpetrated by another political party.
