Executive Order

Exile from the States of the Union and The United States of America

In the matter of
Register of Action 77-CV-16-1137

It is determined by the National assembly for the Government of The United States of America that the Declaration of Interdependence of the WORLD AFFAIRS COUNCIL OF PHILADELPHIA, is in violation of the Law of Nations and the Universal Declaration of Human Rights and is therefore, a direct attack against National sovereignty and this National Government.

It is also acknowledged by the National assembly for the Government of The United States of America, that each person is born free and equal and, endowed with reason and conscience, each person is free to form any and all political allegiances determined to be in the best interest of that person.

Therefore, by the authority vested in the office of the Governor by the National assembly for the Government of The United States of America, the following is hereby ordered:

The Universal Charter of the Judge from the International Association of Judges doing business as Judge DANIEL A. BENSON within the metes and bounds of the County of Todd, State of Minnesota as enforced under the 1976 Declaration of Interdependence and the May 7th, 1933 ancient pledge by Franklin D. Roosevelt is hereby exiled from the metes and bounds of The United States of America and the States of the Union, and

Further, the pledge of DAVID LAVEN as derived from the May 7th, 1933 ancient pledge by Franklin D. Roosevelt to the Universal Charter of the Judge doing business as TODD COUNTY 7TH JUDICIAL DISTRICT COURT is hereby exiled from the metes and bounds of The United States of America and the States of the Union, and

Further, all state statutes in the possession of the Universal Charter of the Judge doing business as Judge DANIEL A. BENSON within the metes and bounds of the County of Todd, State of Minnesota is hereby returned back to the State of Minnesota for judicial review by the people on whether consent was given to be governed by said statute(s) and whether or not the statute(s) is properly vetted to the independence of the State in which it was delivered and benefits the people wherein they reside, and

That, the political decision of association and allegiance to the Declaration of Interdependence, as demonstrated by voluntary signature of the persons so desiring such allegiance, or by the voluntary act of enforcement of its principles conducted by non-signatory persons, be honored by all offices of the Government of The United States of America, and

That, all records of the Government of The United States of America be made to accurately reflect this voluntary adherence to its threat against human rights, and

That, as consequence of such adherence and enforcement, any existing claim or intent to make a claim by DANIEL A. BENSON of residency, citizenship or nationality within the States of the Union within The United States of America, is hereby revoked under pain of involuntary exile, and

That, all offices serving the Government of The United States of America, shall take all necessary action permitted by law to carry out this order.

Nothing in this order shall be construed to impair or otherwise affect:

(i) the human rights of DANIEL A. BENSON except the right to claim a residency or Nationality within the States of the Union or The United States of America to receive ones family heritage; and

(ii) the right of DANIEL A. BENSON, within three (3) days of the date of this order, to formally dispute this order; such dispute to be heard within the Human Rights Tribunal International, a court of proper venue and jurisdiction over such matters.
