Executive Order

Exile from the States of the Union and The United States of America

It is determined by the National assembly for the Government of The United States of America, that certain entities listed under "Addendum A" of this Executive Order, have revealed themselves to be in support of the Muslim Brotherhood, an international terrorist organization attempting the overthrow of the United States, as well as presenting a clear and immediate threat to the life and limb of the people of The United States of America and a threat to the security of the Government of The United States of America.

Therefore, by the authority vested in the office of the Governor by the National assembly for the Government of The United States of America, the following is hereby ordered:

That, all records of the Government of The United States of America be made to accurately reflect this determination of the National assembly for the Government of The United States of America, and

That, as consequence of such terror-based political actions and discourse, any existing or future charter of any named entity herein, and all subsidiaries and communities connected thereto, within the States of the Union within The United States of America, are hereby exiled under pain of involuntary exile, and

That, all members of these entities and all members of subsidiary organizations and communities connected to these entities are hereby declared combatants against the people and the Government of The United States of America, and are to be classified as armed/dangerous, approached with caution and deported without delay, and

That, all offices serving the Government of The United States of America, shall take all necessary action permitted by law to carry out this order.

Nothing in this order shall be construed to impair or otherwise affect the right of these entities, within ninety (90) days of the date of this order, to formally dispute this order; such dispute to be heard within the Human Rights Tribunal International, a court of proper venue and jurisdiction over such matters.
